Shuttle Time has exposed approximately 2000 children last year to Badminton and we continue our focus with the introduction of after school programmes in those areas.

HOWEVER - WE DESPERATELY NEED MORE CLUBS TO CATER FOR JUNIORS FOR OUR SPORT TO GROW

I must congratulate Jenny Zhu and Jack Wang on their selection into BNZ Development squads in their respective age groups. This is a fantastic achievement by both of them.

Whilst talking about juniors, special mention must also be made of our U17 team that finished 3rd in the National Tournament at Palmerston North. Congratulations to you all.

Congratulations to Canterbury 1 on retaining their position in Wisden Cup finishing a credible 5th and also winning the Neil Cup for the 9th time in a row.

At the other end of the age scale, congratulations to the Canterbury 1 Master's team winning the South Island Division 1 competition and Canterbury 3 winning Division 3. In Veterans (over 50's) we also had a clean sweep as well as winning the inaugural 'Super Vets' event.

BNZ have changed their focus somewhat and all associations are now rated Tier 1 or 2. I am pleased to report that Canterbury is a Tier 1 association which means we get more support from BNZ. BNZ staff have been appointed to various associations and it is very pleasing to be able to announce that Joe Hitchcock BNZ CEO has been appointed to Canterbury.

SENIORS REPORT

Well 2017 got off to a rocky start with the unscheduled departure of Jamie, the professional coach BC employed, back to his home country - Scotland. Special thanks must go to Alfred Wong for stepping up and agreeing to coach the senior teams.

Due to the events at the start of the season there was more of a delay in naming teams than I would have liked, but we got there in the end with one Division 1 team and one Division 3 team named. Both teams performed well. The division 1 team competed for the Wisden Cup in Auckland and ended up placing 5^{th -} with a win over Barefoot and Thompson Waitakere 1, 11-5. They also had a close game against Wellington North, only loosing on countback. Our Division 3 team placed 2nd with a loss to Otago 1, 10-6 who then went on to win the playoff against the North Island winners – Counties Manakau. Overall this is a great result for Badminton Canterbury.

Members from our Division 1 and Division 3 team combined to form a team to compete in the Neil Cup in Dunedin where we won for the 9th time in a row! Congratulations to all those involved. Badminton New Zealand have made some significant changes to the format of Division 1 for the 2018 season. For 2018 there will be 5 matches per tie, Men's singles/ Women's singles/ Men's Doubles/ Women's Doubles/ Mixed Doubles. Due to these changes there is likely to be less people selected for our Division 1 team, so we have entered two Division 3 teams for the 2018 season. Good luck to all for the 2018 season.

Canterbury Champs.

Under 13's - Two stand out performances from Jeremiah Manickam and Eve Cudby with each of them winning the triple crown. Really pleasing to see growing numbers of players at this age group.

Uunder 15's - Otago and Southland players came dominated this year but have shown our Canterbury players the standard they need to achieve.

Under 17's - Good all round performances by Jack Wang and Jenny Zhu.

Under 19's – Dylan Chan and Elly Li from Canterbury took out the boys and girls singles respectively amidst a strong contingent from Otago and Southland.

Jamie Neill

Jamie arrived and got straight to work getting to know our players and starting to implement his ideas for growing badminton in Canterbury.

Unfortunately due to personal reasons Jamie had to urgently return to Scotland. This was very disappointing as we could already see he was going to be a great acquisition.

Shuttle Time and Badminton in schools

Megan Heaney continued to work closely with a number of schools as we expose a significant number of school children to badminton and this will be ongoing in 2018 as we try to generate new young players.

South Island Age Group Teams and Individuals.

The under 13's ,15's, 17's and 19's South Island Teams event was held this year in Timaru. A massive thank you to Julie Rademaker for all her efforts with making this a successful event.

Canterbury sent two Under 13 teams and one team in each of the other age groups.

Our Under 13 teams finished first and second. Our under U15 and Under 17 teams both won their age group and our 19's were just pipped to the title by Otago.

INTERCLUB

The 2017 season of interclub kicked off on the 8^{th} May. We started the season with 5 teams in A Grade (same as 2016), 4 teams in B Grade (down from 6 in 2016), 9 teams in Doubles 1 (up one from 2016), and 9 teams in Doubles 2 (up from 6 in 2016). Due to lack of numbers there was no Doubles 3 grade held in 2017 (previously there had been 4 teams in 2016).

A Grade was won by Lincoln Black, B Grade by Fendalton, Doubles 1 by UCBC and Doubles 2 by CABC Spirit Away. Overall the feedback for Doubles 1 and Doubles 2 was positive, however A and B Grade feedback was not so positive, mostly due to the small number of teams and playing the same team every 3rd or 4th week.

Summer League was held from October to December 2017 and attracted a good number of teams -9 in the Tuesday night competitive grade (although one subsequently pulled out), and 7 in the Wednesday night social grade. Summer League has always been a popular finish to the season – playing in the warmer evenings is a pleasant change to the cold, frosty nights!
