## BOARD CHAIR REPORT

As I approach the end of 7 years as chair, I feel it is appropriate to reflect on some of the highlights as I see them.

Undoubtably the rebuild and reopening of our magnificent stadium, must be number one. For this I must again thank Trevor Ballard for the work he did with Naylor Love, our contractors.

The Board decision back in 2014 to restructure our total organization from 2 full time admin staff to that of 1 part time administrator and a full-time paid Coach and Development Manager had a major impact. I must thank Julie for her continued support through this difficult transition. This move put a lot more responsibility on Board members and without exception they all rose to the challenge.

As you know, we now have an acting General Manager, Lou (part time - on contract) and a Coach and Development Manager, Jo (part time - on contract). The board is very much what I would call an Operational Board and not pure governance and that is strong position to be in I feel.

Jo's role is critical to the direction BC is taking. The BWF led Shuttle Time programme requires considerable organization. Jo has 5 hubs running around Canterbury and has many Shuttle Time coach training courses. This has led to considerable growth in junior numbers as has the opening of Zhu Badminton Centre where the School of Badminton focusses on juniors' players.

Jeanna's role as Event Manager and now master's convenor is also incredibly significant in our organization.

The other major role on the board is that of Junior Convenor. Matt Selen spent 5 years in this position and did a sterling job. This is now done equally as well by Dawn Canovan and her committee.

Canterbury has continually led the fight against the unfair system that BNZ use to gather affiliation fees and I am delighted to say that at last a working group has been set up by BNZ to revise this system and Tony Davey, our Treasurer, is one of this group. I can assure everyone that I will be maintaining a very keen interest on this outcome.

Despite this I am delighted to say that BC now has a great relationship with the Staff and management at BNZ. BNZ are incredibly supportive of our programmes. This has not always been the case unfortunately.

Canterbury has taken on a lead role with Mainland. This organization is again working well. Our central position and the ability to use 20 international standard courts has given us the 'preferred venue' status for the South Island Masters and it is also fantastic to see the resurrection of the 'South Island Junior Team Championships'.

On a sadder note, I must record the passing of life members, George Miller, and Jean Crawford-Stewart. I have spoken at length in the past of Georges achievements but as Jean has only just passed on, I would like to acknowledge her input. Jean was the bar and shop manager for many years and her happy smile will be sadly missed. Her role also in the Avon Club has been incredibly significant.

Finally, thank you to all the Board members both past and present for your support throughout the last 7 years. It has been an interesting journey and I wish Badminton Canterbury well. I am confident that Matt Selen who is taking over from me as chair will continue to 'steer the ship' in a positive manner.

As with all sports, the senior badminton calendar was hugely affected by Covid-19. Despite the shortened time-frame, there was some play and a competitive season was held.

The first main tournament of the year was the St Paddy's Open in March, where 83 players competed over two days. The standout performance of the tournament was Jack Wang winning triple titles in his final season in Canterbury. Jack moves up to Auckland for university in 2021 and we wish him well. Other titles were shared by Elly Li, Alfred Wong, Yuri Minagawa, Megan Heaney, and Jenny Zhu.

In the Canterbury Open, 73 players competed. This tournament also featured triple titles, this time to Elly Li at the age of just 15. Other titles were shared by Avinash Shastri, William Chen, Alfred Wong, and Yuri Minagawa. Well done to all players, and thank you to those who travelled.

### **Representative Teams**

With Covid, NZ's Wisden and Slazenger Cups were cancelled for the year, marking the first time in many years that these events have not been held. In its place, a two weekend combined division one and two event was planned. Unfortunately, this was also cancelled due to the second Auckland lockdown. Whilst it was disappointing for our players, the team were at least able to do some training. Badminton NZ made the best of a bad situation with the creation of the NZ Badminton League which was fantastic to watch. We look forward to the growth of this event.

After being relegated from Slazenger Cup, the second team competed in division three along the third team. Canterbury II had some very tight games, narrowly losing the South Island title to Nelson 6-5. Canterbury III won section B of the draw with wins over Otago II, Southland II, and an invitational team.

In the South Island Neill Cup, Canterbury went in with high hopes, looking to win for the 12th year in a row. Unfortunately, it was not to be, with Canterbury posting losses to both Otago and Southland. Congratulations to hosts Otago who won the trophy.

Thank-you to all people who have made badminton this year possible. As always, we extend our gratitude to Alfred Wong for his coaching and support of the senior teams.

2020 has been a remarkably interesting year for the juniors with Covid 19 putting a halt to tournaments and travelling.

Juniors continue to grow in Canterbury especially noticeable at the Zhu badminton centre with increased private coaches and groups.

Where it was possible the Mainland Development Camps were held over the year with players, when able, travelling from over the South Island. The development camps are an amazing opportunity for the juniors not only for friendships but to be spoilt with all the amazing coaches that give up their weekends to help enhance the juniors.

We also sent the June Bevan Team and one u17 Canterbury junior to Wellington for a development camp held by BNZ. It was a great experience by all in being taught by Jo Christie, Alfred Wong and Rikke Olsen Siegemund among other coaches from the central region.

For the first time BNZ held a selection camp for the U15s here in Canterbury where kids were asked from Southland, Otago, Blenheim, and Canterbury to attend and 5 juniors were selected to join the BNZ development camp. This is such an amazing opportunity for our kids. We thank BNZ for listening to our feedback, that sending one child up to Auckland to trial (in 2019) was not a fair system and was very daunting for our players.

### **Junior B Grade**

We had a successful B Grade interclub for juniors which had 6 teams and ran for 7 weeks, the kids got so much from this and will now be run yearly.

### **Representative Teams**

In October, Canterbury held the South Island champs and Canterbury were immensely proud to be able to enter so many teams, giving every child who wanted to represent Canterbury the chance to. We entered 2 U13s, 2 U15s and 2 U17s. As the under 19s had missed out due to lockdown they had a chance of being involved in the South Island tournament as well and we allowed an invitational team to enter the Under 17 competition.

Our amazing under 13s came first and second in their group, with our under 15s and U17s just missing out and coming second in the tournament.

Well, 2020 certainly goes down in history as one of the most bizarre with a world pandemic thrown into the mix. Planning and replanning would probably sum up the year for me.

### Shuttle Time

A huge thanks to my Shuttle Time coaches, Carrie Wilson, Yuri Minagawa, Yuko Black and Manny Collins who worked really hard during some challenging times where managing groups of children while trying to maintain physical distancing as much as possible and when sanitising shuttles and rackets became a thing! They remained flexible during times of cancelled sessions and the extra recording required.

In 2020 we recorded 1300 participants in the Shuttle Time Programme which is down on last year. This would have been influenced by the cancellation of the events listed below.

- We also found a drop in the number of primary schools that we were involved with was reduced due to COVID. Schools were really focusing on the children's wellbeing and were not getting outsiders into the school as they would normally.

One Shuttle Time Coaches Course was held on 2<sup>nd</sup> August with 7 participants. For 2020 we unfortunately did not manage to fit in any upskilling sessions for our Club Coaches, due to COVID. But I do want to thank you for your continued support by providing figures to me when requested (which I pass on to BNZ and Sport Canterbury) and delivering Shuttle Time to the kids in your local area. There are so many children playing badminton in Christchurch now, which is amazing to see. We will look to get back into running some upskilling sessions for club coaches in 2021.

We held two Shuttle Time Yankees in 2020, one on 19<sup>th</sup> July and was a great success with 21 children playing and learning how to umpire and one on the 20<sup>th</sup> of September, which had 20 entries. Thanks to Canterbury Badminton Shop, Cookai Japanese Restaurant, City Putt n Cruise, Clip n Climb and Supa Karts for their continued support in providing prizes for these tournaments.

### Regional Coaching Days

Regional coaching days were again a success – we had 33 attend the first session in February and then 32 attend the next one in July. The Regional Coaching days form part of our trails for Representative Teams and we have as many coaches as possible there on the day helping with the different groups of kids from U13 through to U19.

### South Island Age Group Championships

We were lucky and did manage to run the South Island Junior Team Championships here in Christchurch, which was a hugely successful tournament with 21 teams entered. A massive thanks to our team coaches Alfred Wong, Amanda Hardy and Tegan Weston who put in a lot of work training these children and looking after them at the tournament. Thanks also goes to our team managers for all their hard work.

Our sponsors for this tournament were Bernald Wong – Canterbury Badminton Shop, Alfred Wong – Cookai Restaurant, ANZ, Christchurch NZ, Christchurch City Council and Pak n Save Wainoni for their support in creating some great player packs for the kids.

### Mainland

For the 2021 season Badminton Canterbury had the following players selected into the BNZ U15 Development Squad: Ashley Bonne, Kate Duffield, Emma Canovan, Jay Xuan Tan. Jack Wang was once again selected into the NZ U19 Development Squad however he has now moved to Auckland for his tertiary studies and has changed associations.

After many years of suggesting that Mainland be able to enter a combined team into the New Zealand Junior Team Championships, held in Palmerston North – Badminton New Zealand has proceeded with a change in format. They now offer two Divisions and have allowed Mainland to enter combined teams into Division 1 for 2021. Our priority is, and will always be, to put forward a Canterbury Team into this competition where possible, but for 2021 after feedback sought from parents, we nominated children for the combined teams.

For 2021 Mainland is entering 1 under 15 team, 1 under 17 team, and 2 under 19 teams into the Division 1 competition in July. Congratulations to Jay Xuan Tan, Baxter Lin, Ashley Bonne, Kate Duffield, Emma Canovan and Anna Kim who were selected to represent the Under 15 team; Katie Canovan, Emma Crossland, Juhee Park, Logan Barnes, and Jeremiah Manickam who were selected for the Under 17 team, Sam Duffield, Alejandro Ballard and Elly Li who were selected for the Under 19 team.

Christchurch hosted the South Island Junior Secondary Schools Cup which was run by BNZ. There were relatively low entries, especially in the boy's competition, but this enabled BNZ to run a relay style event for them on the second day, which was lots of fun. Feedback from the teachers was that they were incredibly pleased with how the tournament ran and they promised to spread the word and support this more next year.

Dawn Canovan has again worked extremely hard in her role as Junior Convenor for 2020. The families, I am sure, are incredibly grateful for all the organising you do behind the scenes and all the effort that goes into organising and running fundraising events. Having a Junior Convenor that is 'on the ground' helping with enquiries from families and communicating on behalf of BC is invaluable.

This year we changed up our Annual Awards and held a Halloween Yankee prior. There was a great atmosphere in the hall with lots of players dressing up and having some fun. Thanks to Veenuz Indian Restaurant and Hello

Vietnam for providing meal vouchers. Prize giving followed, with a good turnout – thanks to Carrie who prepared the food for this.

Masters continued to hold their Sunday night sessions throughout 2020, when Covid restriction allowed. We were able to proceed on the tournament on the 11<sup>th</sup> July, and ended up with 33 players competing, including several from Otago and the West Coast.

The SI Masters Teams Event was again held in Christchurch, albeit an abbreviated version! Due to some players not wanting to travel, we ended up with 14 teams competing over 2 days at both Pages Road and the Zhu Centre. Both Canterbury Red and Canterbury Black enjoyed some tough games in Division 1, with Canterbury Black winning the division. In Division 2, Canterbury 3 won 2 out of their 3 games, and finished 3<sup>rd</sup> (just being pipped by the West Coast who finished in 2<sup>nd</sup> place on countback). Canterbury 4 cleaned up in Division 3, only dropping 2 matches the entire weekend! A very enjoyable social evening was held at the Russley Golf Club and was well attended.

The SI Vets Teams Event was held in Christchurch, with 12 teams (76 players), all age 50+ from around the SI playing. A very strong Otago team took out Division 1, with Canterbury 1 finishing in 4<sup>th</sup> place. Canterbury 2 finished 3<sup>rd</sup> in Division 2, and a combined Canterbury/Otago team finished 2<sup>nd</sup> in Division 3.

Several players from Canterbury attended the 2020 NZ Masters Games in Dunedin in early February, coming away with many medals! We also had an enjoyable weekend attending the Dunedin Masters Champs in October.

2021 sees the return of Super Vets Teams Event, which is being held at stunning Franz Josef over Anzac Weekend. The SI Masters Teams Event is again being held in Christchurch this year as well, and I'm looking forward to a return to the normal schedule over Queens Birthday Weekend. The SI Vets Teams Event is being held in Timaru later in the season.

I have been attending the Sunday night masters sessions this year, and it has been wonderful to see the big numbers turning up, including some new (and old) faces – long may it continue! Happy playing 😊.

The 2020 season was an abbreviated version, thanks to Covid. We managed to get the St Paddy's Tournament played on the 13<sup>th</sup> and 14<sup>th</sup> March, prior to lockdown, with 85 participants over the Open and B Grade sections, and some excellent games. Due to Covid restrictions, several other tournaments were rescheduled for later in the season, meaning that most of our tournaments were condensed in to a 3 month period.

The Canterbury Open was held on the 4<sup>th</sup> and 5<sup>th</sup> July and was again well supported, with 73 participants. This was followed by the Canterbury Masters Champs on the 11<sup>th</sup> July, the South Island Masters Teams Event on the 24<sup>th</sup> and 25<sup>th</sup> July, the SI Senior Division 3 from the 7<sup>th</sup>-9<sup>th</sup> August, the SI Vets Teams Event on the 22<sup>nd</sup> and 23<sup>rd</sup> August, the Canterbury Secondary Schools Teams Event on the 31<sup>st</sup> August/1<sup>st</sup> September, the Canterbury Secondary Schools champs on the 2<sup>nd</sup> and 3<sup>rd</sup> September, the Canterbury U13/U17 Tournament on the 12<sup>th</sup> and 13<sup>th</sup> September, and finally the SI Junior Teams and Age Groups Champs from the 27<sup>th</sup>-30<sup>th</sup> September (featuring 90 junior players from throughout the South Island).

In between this Senior Interclub was also held from the 29<sup>th</sup> June through until the 28<sup>th</sup> September, with 4 x A Grade teams, 7 x Doubles 1 teams, 6 x Doubles 2 teams competing, and it was fantastic to see 6 x B Grade teams playing weekly too! A huge thank you must go to Trevor Ballard who ran (and continues to run) the Thursday night social grade, with full courts each week.

Having had time to reflect on the year that was, I would like to thank all the players for continually supporting the Badminton Canterbury Tournaments last year. We were incredibly lucky to be able to hold the events that we did, and it was great to see not only the same familiar faces returning, but also the number of new players showing up as well. 2021 has started with a record number of entries in the St Paddy's Tournament (132 players!). I look forward to (hopefully) a normal season ahead!

The year 2020 was the 60 anniversary of the time Badminton was first played on the new 4 courts built at Val Skellerup Hall, Pages Road.

Prior to the construction of the new 4 court Badminton specific hall all Badminton was played in church halls or in commercial buildings, none of which were really that suitable for the game of badminton.

The new Val Skellerup hall was constructed by members, who contributed a recorded 4,500 hours of voluntary labour to complete the hall in May 1960. The new Hall was named after Val Skellerup who was responsible for calling a meeting to initiate a building fund to construct a Badminton specific building. The official opening of the new Val Skellerup Badminton Hall was held in May 1961 which is exactly 60 years ago at the start of badminton competition in May 2021.

Without the voluntary effort put in by those past members 60 years ago we would not be able to enjoy playing on a Badminton specific hall today. In recognition of their incredible voluntary effort the 2020 Social grade teams were named after the 1959 Finance and Building committee. Their names will be again used for the names of the 2021 social grade teams.

As I write this it is now April 2021. Looking back over the last year, all that can be said is the Social grade had a great but short year of Badminton Competition in 2020. Although social grade badminton was not played during the first two school terms because of Covid19 lockdown and its associated issues, we still managed to organise a social grade competition for the 3<sup>rd</sup> school term as well as the first social grade competition for summer league held during the 4<sup>th</sup> school term, October 15 to December 17. For social grade summer league, we had enough players entered to make up 16 teams.

There are many keen social grade members and some badminton hungry players have organised themselves into a group who have booked 2 to 3 courts each Thursday night 7pm-9pm for Term 1 of 2021, prior to Autumn League starting.

In 2020, the emphasis was placed on social, friendly games yet still with a keen competition. Teams were again split into a Red Grade (Generally ability B to D grade) and Black Grade (D-F grade) according to players ability.

We had two competitions in 2020 and so we had two finals nights, which were held on the last night of each competition. Two players per team organised to bring a plate of supper which was held in the upstairs lounge. Jared Philips opened the bar and John Morrish, the Chairman of BC, presented prizes. Various players took control of organising the kitchen and organised the supper which was nicely put out on the tables. I have no idea who those players are, but they need a big warm thank you from all the other players.

Throughout the 3 competitions complementary tea and coffee was again provided other than for the summer league, in the room adjacent court 8, where about 60% of the players enjoyed these hot drinks during the winter months.

Without exception all the social grade players have been the major part in the success of the two competitions. The social grade players are a great group of players to be involved with. In particular I would like to mention Irwin Wallace who organised the tea and coffee refreshments each Thursday night and all the team captains who helped to organise their teams. A big special thank you must go to Grant Browne and Sarah Burt for taking over the EFTPOS machine which made collecting the \$8 per night players fees much easier to do. The final night prizes were arranged by the following players: Third school term - both competitions prizes organised by Murry and Julia Eves; The purchase and wrapping of prizes for the summer league became too much for one person to do so Jacqui Taylor organised the Black grade prizes while Pam Badder organised the Red grade prizes. Also, Jared Phillips took over operating the bar. Last but not least, are David Keast and David Drayton who were two of the original 4 old buggers who started the social grade and are still keen to be involved.

The introduction of the social grade competition would not have succeeded without the help of three affiliated clubs which should be recognised. They are Windsor Club, Lincoln Club and Avon Club. But most important of all is John Morrish BC chairman who gave the social grade the freedom to organise their own competition, to suit their own requirements.



In conclusion I would say that the success and growth of the Social Grade can be attributed to the simple fact the social grade is a players' run competition no longer relying on the office administration or the support of affiliated clubs. All involved have a focus on good communications between players. 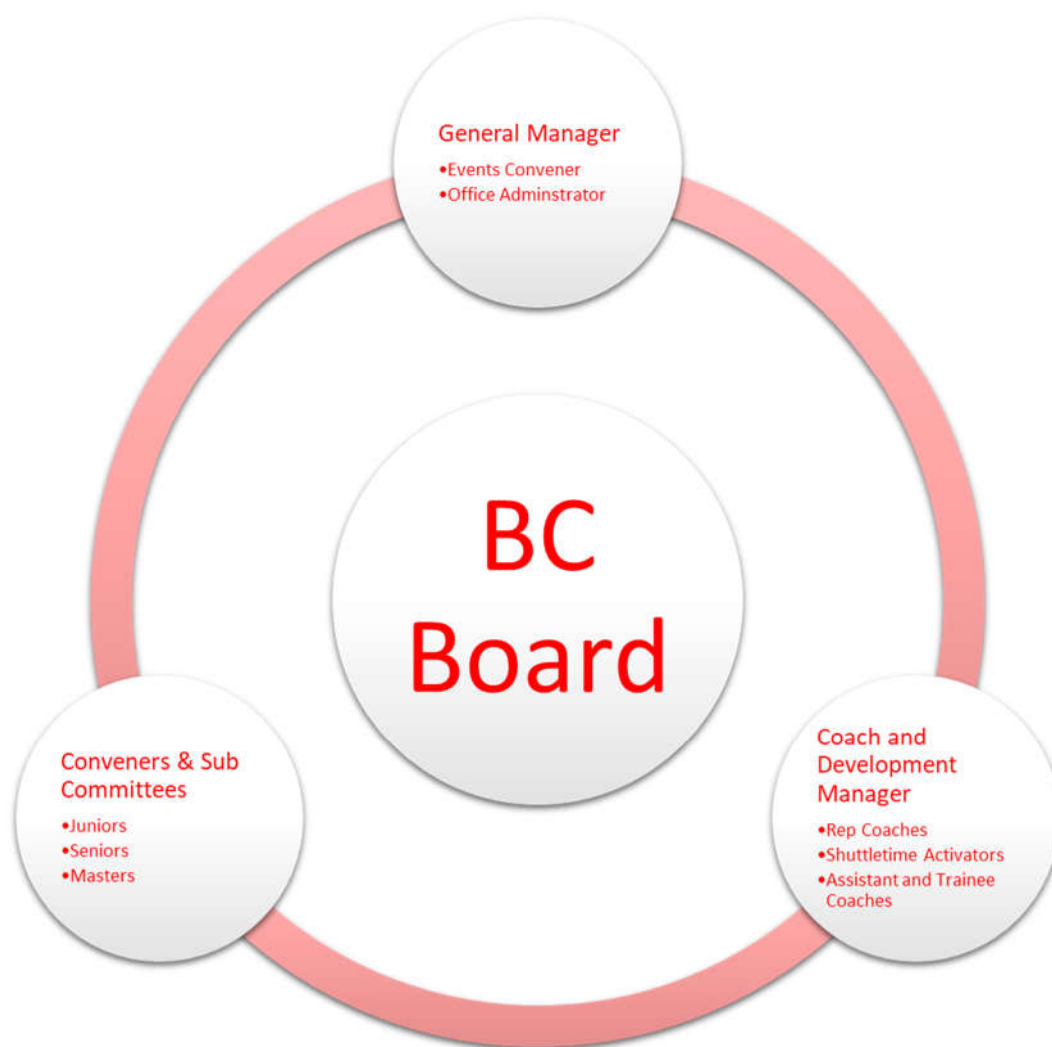



The financial statements presented here are for Badminton Canterbury Incorporated, a Charitable entity under the Charities Act 2005.

Badminton Canterbury Incorporated has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000.

The financial statements have been prepared on an accruals and historical cost basis, with the exception of certain items for which specific accounting policies have been identified.

(a) **Changes in Accounting Policies**

There have been no changes in accounting policies. All policies have been applied on bases consistent with the previous year.

(b) **Fixed Assets & Depreciation**

All fixed assets are initially recorded at cost (with the exception of the Hall & Buildings which were revalued in October 2016) with depreciation being deducted on all tangible fixed assets other than freehold land, in accordance with rates set out in the Income Tax Act 2007.

(c) **Goods & Services Tax**

The financial statements have been prepared on a GST exclusive basis with the exception of accounts receivable and payable which are GST inclusive.

(d) **Income Tax**

Badminton Canterbury Incorporated is registered as a charitable entity under the Charities Act 2005 and is therefore wholly exempt from paying income tax having fully complied with all statutory conditions for these exemptions.

(e) **Receivables**

Receivables are stated at their estimated realisable value. Bad debts are written off in the year in which they are identified.

At balance date there are no known commitments or contingent liabilities (2019:\$0).

#### 3. EVENTS AFTER BALANCE DATE

There were no events that have occurred after balance date that would have a material impact on the Performance Report.

At the end of 2019, I wrote about the areas that we were to put our effort into for 2020-21, finishing with 2018 was the year of change, learning and growth, 2019 a year of doing things better, and 2020-21 was to be a time of refinement and improvement. The best laid plans however can get side-tracked with a worldwide pandemic to deal with! Sitting here in Christchurch we are somewhat sheltered from the rest of the world, but it is fair to say that Covid has had a substantial impact on Badminton Canterbury, our clubs, community organisations, and our players.

Out of the turmoil, there has been some positives to rise for us, including the use of technology. By way of Zoom meetings, I have been able to participate in an event working group with Badminton NZ, allowing us to ensure Canterbury's opinion and input is contributed to what happens at a National level. We also have a strong collective in Mainland Badminton (the South Island combined associations) which leads all the SI events, and again using online meeting platforms, the Mainland group is working together strongly to further badminton across all South Island Associations and competitions.

Focusing at home, the board and management team have been reviewing various items of the previously developed strategic plans. Rather than creating plan after plan, document after document, we have adopted a more practical approach; that is taking the key areas that shape our badminton work (as identified in 2018) and started reviewing what each of these areas mean to us and how we can improve them.



In reviewing these areas, we are identifying what we are doing well, and what we can improve on, as well as developing systems around it, and seeking feedback from various stakeholders (players, clubs, coaches, Badminton NZ and Sport Canterbury). It is this process and the subsequent feedback that allow us to form the direction of BC, to meet the needs of all groups playing badminton to further the sport.

Our clubs and players will be starting to see the results of the board's commitment to betterment – while the board discusses improvement of communication the practical things you will see as players and clubs are things like direct, clear, communication (emails) with clubs, and the (re)introduction of Junior and Senior Player Handbooks for our rep players.

As we adjust once again to a Covid/post covid environment, it's essential that Badminton Canterbury keeps the badminton community at its heart. We need the ability to look outside what we have always done to adapt to the changing face of badminton, and indeed sport; improving the delivery of our sport but still remaining player focussed.
