BOARD CHAIR REPORT

At the risk of repeating the previous chairman's reports of the last couple of years, it has certainly been a challenging 12 months in all aspects of our lives, let alone Badminton in our region.

Without dwelling too much on the past, I'd like to take this opportunity to thank everyone involved in Badminton in Canterbury for all your efforts to allow us to have some sort of normality where possible. Not only the staff here at Pages Road; Lou, Jo, Julie, Jeanna and Leiza, who have done sterling work putting plans and procedures in place to allow play to continue, but I want to acknowledge the coaches, administrators and volunteers at all the other clubs and facilities in the region for their efforts over the last 12 months. And a quick thanks also to the Board members who have been patient with the new Chairman this year as he finds his feet. Thank you for giving up your time to be part of the Board.

What has been pleasing through all the disruption, is the growth we are seeing in player numbers across the region. Facilities are busy, to the point where demand is outstripping capacity during peak periods. Vaughan is tasked to report back to the Board with an unbiased independent assessment of our successes and failings.

A big year ahead for us with Canterbury hosting the Wisden and Slazenger Cup. An amazing chance to showcase Christchurch to the NZ Badminton community, so please get involved and help support this event in any way you can. Another busy year ahead for our Masters, Senior and Junior rep teams, and continuing to give opportunities to casual and social players.

Enough from me, good luck to everyone this year. Fingers crossed for a 'normal' year so we can all get on with the sport we love.

SENIOR CONVENER REPORT

Another disrupted year however tournaments were able to be played.

St Paddy's tournament was a huge success in 2022 with 128 players entered over the A and B Grade.

For A grade Dylan Chan took out the Men's Singles, Elly Li the Women's Singles, Alfred Wong and Frank Zhao the Men's Doubles, Yuko Black and Yuri Minagawa the Women's Doubles and Alfred and Elly the Mixed Doubles.

For B grade Riwaj Dhakal won the men's singles, Juhee Park the Women's Singles, CK Chiong and John Ngo the Men's Doubles, Sarah Le Page and Carrie Wilson the Women's Doubles and Wasim Taj and Saranya Duraisamy the Mixed Doubles. The success of this tournament has meant that for the 2022 season the tournament was played over a Saturday night and Sunday, rather than the traditional Friday night/Saturday.

The Canterbury Open had 93 players, up 20 from last year. Luke Falvey won the Men's Singles and combined with Jun Kit Ng to win the men's doubles, Elly Li won the women's singles and Otago pairing Pingkan Polek and Lucy Thompsen won the women's doubles. The mixed doubles was won by Alfred and Elly.

Representative Teams

This year, Wisden and Slazenger cups were able to be held at Badminton Waitakere. Our team consisted of Anu Ahuja, Dylan Chan, John Morahan, Charles Sham, Alfred Wong, Michelle Foong, Marcia Ho, Jenna Selen, Kira Selen, Tegan Weston. They ended up placing 5-8th in Slazenger Cup.

The long-contested Neil Cup took place here in Christchurch. Our team were very determined to bring the cup back after losing it last year, and did so defeating Otago 7 - 4, Southland 7 - 4 and Nelson 8 - 3. Well done!

Canterbury had two teams in the South Island Division 3 Inter Association competition, it was great to see some of our top juniors coming through and competing at the senior level. Our Canterbury 2 team placed second behind Southland who won 9 - 2 and the Canterbury 3 team placed 4^{th} .

JUNIOR CONVENER REPORT

One of the main focuses for the last year was fundraising for the teams events, which the families worked very hard on. From the BBQ's at Bunnings and Mitre 10 to running the Cafes at Zhu and Badminton Canterbury it has been a huge effort and I would like to thank everyone for their help running these, as we couldn't do it without the parents support. It has made the team events affordable.

The decision was made last year, due to a poor response from the Canterbury players to attend Nationals, that a Mainland team would be selected for this event. We had three camps, one in Christchurch, one in Dunedin and one in Invercargill. It was an amazing experience for all including having a different coaches' perspective. We were also very fortunate that Nic Raines was able to secure funding for the team and with the fundraising efforts it was affordable. The venue was amazing and we opted for catering which took a huge task off the managers. The under 19s B team were the only team to place, getting 3rd - well done team, with the other teams just missing out at 4th and 5th. With a huge thanks going to all the coaches and managers who give up their time for the teams event.

Once again COVID 19 reared its head and our South Island event wasn't able to go ahead which was disappointing for all, then Nationals individuals U19 and U15s followed suit. BNZ ran a summer series in January which 6 Canterbury children attended. 3 of our Canterbury kids were also selected for the U15s BNZ training Squad.

This year we are able to send one U19s one U17s and an U13s team to Nationals, we are sending a Mainland U15s due to the lack of U15s around the South Island.

SHUTTLETIME & DEVELOPMENT REPORT

Another disruptive year unfortunately due to the Covid pandemic, with tournaments cancelled for our young athletes.

Shuttle Time

Our Shuttle Time coaches for the 2021 season were Yuri Minagawa, Yuko Black, Chloe McMurdo, Manny Collins, Tom Chen, Derek Chow, Carrie Wilson and myself. Again, they were flexible with the extra requirements placed on them due to Covid and I thank them for their efforts in keeping badminton going!

Across BC Shuttle Time after school programmes, we had the following participants:

- Term 1 37 males/41 females
- Term 2 40 males/37 females
- Term 3 46 males/ 43 females
- Term 4 33 males/ 42 females

Across all clubs providing Shuttle Time programmes to juniors, we had 1458 participants which is up slightly from last year.

I held a Shuttle Time Coaches/Youth Leadership Award Course on 30th May with 4 completing the Shuttle Time Course and 7 the Youth Leadership Award. Just a reminder to all clubs – that this is a great introductory qualification to coaches and any juniors that are starting to help at clubs. It provides them with some useful skills around the 'Art of Coaching' and teaches them how to use the Shuttle Time app – which is a free resource for anyone coaching badminton. Please encourage your older juniors to complete this course as it is also something they can put on their CV. The second scheduled course for 2021 was cancelled. No Coach upskilling sessions were held during 2021 due to a lack of interest by clubs.

Our Shuttle Time Yankee tournaments were held in April (14 participants), July (12 participants) and October (10 Participants). This year we have rebranded this event to be called the Shuttle Time Carnival, in line with Balance is Better guidelines. It is not a 'tournament' but rather a fun day for players to have the opportunity to play against children from other clubs and get support from our older juniors around the rules of the game and umpiring. Please encourage your club or Shuttle Time players to come along to this event, there are spot prizes and pizza afterwards.

Thanks to City Putt and Cruise, The Antarctic Centre, SupaKarts, Clip n Climb for their continued support of this event.

Regional Coaching Days

Our Regional Coaching Days provide players in Canterbury an opportunity for an intensive training session with BC's top coaches. They are suitable for all players that are of the 'Silver' standard or above on the BNZ Incentive Award Scheme. Our selectors are also present at these training days so that selection into teams isn't purely based on results from games. They are also looking at training attitude and effort.

Our regional coaching days were again a success – to the point we have had to separate the age groups out for the 2022 season. We had 46 players attend in April and 34 attend in July across all age groups. Thanks to the all the coaches who assisted in making these days a success and our selectors Esther Bonne and Felicity Leydon-Davis.

New Zealand Junior Team Championships

For the 2021 season Mainland entered combined teams into the NZJTC which thankfully was able to go ahead. After a few years of there being an U15 Mainland Development Squad, it was great to see this carrying on to the U17/19's age groups.

Mainland U15 – Finished 5th Mainland U17 – Finished 5th Division 1 Mainland U19 Team 1 – Finished 5th in Division 1 Mainland U19 Team 2 – Finished 2nd in Division 2

South Island Age Group Championships

Unfortunately for the 2021 season this event was cancelled due to Covid. BC was going to be in a strong position for this tournament with several teams looking to travel to Dunedin. We were looking at two teams entered into the U13/15/17 age groups.

I would just like to take this opportunity to thank our Representative Team Coaches, who unfortunately didn't get to see the results of all their hard work; Yuri Minagawa, Yuko Black, Tegan Weston, and Alfred Wong. Thanks also to our junior selectors Esther Bonne and Felicity Leydon-Davis. The South Island Age Group Championships will be held in Dunedin for the 2022 season, and we look forward to a great tournament.

With thanks to the Lion Foundation – we were successful in funding 50 BC representative playing tops for our Juniors to use, helping to reduce one of the financial costs involved of playing reps. They also funded a minibus for our juniors travel to Dunedin which we didn't get to use.

Para Badminton

Carrie has been regularly coaching a group which varies between 4 and 7 players. Michelle Au from BNZ has also been down to Christchurch and run training camps with these athletes and Carrie herself. With the growth in our participation numbers in Para Badminton, we were able to get access to our hall changed this year. Our wheelchair athletes can now enter via new double doors, straight into the hall by court 5. A wheel-chair friendly, emergency exit has also been installed. Thanks for your work in this area Carrie – it's great to see the increase in the number of para-athletes playing badminton.

Voice of the Participant Survey

With the help of Brent Miller and Sam Petterson from BNZ, BC Conducted a Voice of the Participant survey during 2021. Thankyou to everyone that took the time to complete the survey. These results are used to help us shape what we are doing.

We took the results of the group survey further and met with a couple of high schools to gather more insights into our Rangatahi. We are pleased to say that for term 2 2022, we are introducing a Friday night social badminton session at Pages Road.

With the financial support of Sport Canterbury, have also sought the expertise of Vaughan Utteridge from Serious Fun to help us work through a review of our Strategic Plan.

Dawn Canovan – Junior Convenor

Once again Dawn Canovan, our Junior Convenor has worked tirelessly in her role. She does an amazing job at keeping all the families informed as to what is going on and does a fantastic job organising fundraising opportunities for all our players and their families. Fundraising significantly reduced the cost of the tournament for players travelling to the NZJTC and the money for the South Islands will be carried over to the 2022 season. Dawn has unfortunately stepped down as Junior Convenor, but she is very passionate about the benefits of fundraising and will continue to organise this going forward. Thank you so much for your hard work while in the role of Junior Convenor, you have done an amazing job and will be greatly missed.

Although 2022 season has got off to a rough start again due to Covid, with several our badminton community being ill with the virus, I hope that we can get over the peak of the outbreak and enjoy an exciting season on court!

In Division 2, both Canterbury teams had some good matches, and were only beaten by Otago Blue who won the division, with Canterbury finishing 2nd and 3rd. In Division 3, Canterbury had been able to add an additional team due to the large number of Masters players, and this team ended up finishing in 2nd place. It was a great weekend for all Canterbury players, and showed the true depth of masters players around at the moment. A very enjoyable social evening was held at the Russley Golf Club and was well attended.

The SI Vets Teams Event was postponed during the season due to Covid restrictions, and was eventually held in October in Dunedin. In Division 1, Canterbury finished second to a very strong home team. Canterbury were only able to enter one team due to the timing of the event, however this year the Vets is being held in Christchurch, and I'm anticipating 3 Canterbury teams being entered!

The Super Vets had a fantastic weekend away in Franz Josef over Anzac Weekend – it's great to see the number of people still able to play in this age group – I'm sure it's something we all aspire to!

EVENTS CO-ORDINATOR REPORT

The 2021 season was largely a 'normal' season, and it was great to get a large number of events played without interruption. Several new events were introduced and were well received.

15FEB – Pre-Season Doubles Tournament – a new event with 27 players 03MAY - Interclub - 18 teams over 2 grades on Monday and Tuesday evenings 12/13MAR – St Paddy's – a huge 132 players entered in the Open and B Grade sections, and some excellent games. 22/23MAY – U15 and U19 Tournament – 59 super keen juniors 04-06JUN – South Island Masters Teams Event – 179 players age 35+ from around the South Island (more details in Masters writeup) 19/20JUN – Canterbury Open – 93 players 03JUL – Mid-Winter Doubles Tournament – a new tournament that attracted 60 players 10JUL – Canty Masters Champs (more details in Masters writeup) 16/17JUL – Neil Cup – Canterbury winning over Otago and Southland 30/31JUL – Canty B Grade Champs – 61 players 09/10AUG – Canty Secondary Schools Champs 25SEP – U17 Tournament 26SEP - U13 Tournament 18OCT - Summer League started with just 6 teams entered

A huge thank you once again to Trevor Ballard who ran (and continues to run) the Thursday night social grade, with full courts each week.

Having had time to reflect on the year that was, I would like to thank all the players for continually supporting the Badminton Canterbury Tournaments last year. We were incredibly lucky to be able to hold the events that we did, and it was great to see not only the same familiar faces returning, but also the number of new players showing up as well. 2022 has started with large entries in the St Paddy's Tournament, and hope of a full and uncompromised season ahead.

Jeanna Riley Events Convener This year I will be 83 years of age and it is probably my last year of writing about the Social Grade Competition. With this in mind my report this year will reflect on my experience during the last enjoyable 6 years of the Social grade Competition.

In 1976 when a beginner at age 45 I was invited to play in the weekly Interclub Presidents 3 grade competition with 6 players in each team. This eventually changed into Doubles 3 interclub competition sometime in the 1990's with 4 players in each team.

Between the Presidents 3 grade and the Doubles 3 grade competitions I have played interclub for well over 36 years. It's worth noting that between 2002 and 2016 the recorded total number of people playing interclub competition reduced from 298 players in 2002 to a low of 133 players in 2016 (last recorded number of players produced for the 2016 AGM) i.e. a 55% reductions in people playing in all Badminton Canterbury organised interclub competition.

Unfortunately, the doubles 3 competition which I was playing in became the casualty of the decline and cancelled (refer recorded board minutes) due to the lack on team entries from the affiliated clubs. The short cancellation notice of the Doubles 3 Competition resulted in 5 keen badminton players being tossed onto the scrap heap.

Because of the above the 5 discarded players all over 70 years of age got together and decided to organise their own Doubles 3 competition. The then chairman of the Board John Morrish gave his support for the Competition and the current Social Grade commenced with an 8-week competition of 4 or 5 teams.

The preparation of each competition draw, score sheets and collection of the players nightly fees were organised by the 5 volunteers. Badminton Canterbury booked the courts and supplied the feather shuttles. I estimate the total players fees for the first 8-week competition was approx. \$1,120.00

From very unlikely beginnings of an 8-week competition some six years ago, today the original volunteers organise with the help many other willing volunteers, three separate competitions each year. Held during the 2nd School Term (Autumn League), 3rd school term (Winter league) and 4th school term (Summer League).

In 2021 the Summer League had grown to nineteen teams which exceeds the sixteen-team court capacity of Badminton Hall. Each Thursday during the Summer League three teams were forced to have a Bye week. i.e. 12 players wanted to play but not enough baddy courts.

It would be wrong to put the growth of the Social Grade down to one person. Just like in any business it is the employees who do the actual work, or in Badddy the real work is done be the many volunteers.

I believe the success of the Social Grade can be put down to:-

- 1. We have so many special Volunteers who were allowed to operate as they wish without any roadblocks.
- 2. We only have one rule everyone is to have fun, grumpy people are not welcome. Everything else is flexible.
- 3. All new and existing players are made to feel very welcome.
- 4. Good 24/7 communications by text or email.
- 5. Everyone is welcome and we never turn a player away.

6. Teams don't play to win a cup, but all players are presented with a small prize on the final night of each competition - hopefully by the Board Chair.

7. The Social Grade is divided into two sections - a Black Grade with approx. D3 player ability and Red Grade with approx. D2 player ability

The Social Grade players very in age from U13 –U17 Canty rep players, to a few more mature players, some of whom are over 80 years of age.

In 2021 the same original volunteers organised 3 separate competitions of 16 teams playing in the Autumn league, 18 teams playing in the Winter League and a 19 teams playing in the summer League. Unfortunately we lost 5 weeks of competition in the Winter League because of Covid requirements.

The gross income from players fees in 2021 is about \$12,823 which is down on the \$15,264 estimated because we were unable to play for five weeks in August and September 2021 due to Covid restriction.

I personally need to thank David Keast, David Drayton, Irwin Wallace two of whom are over 80 and with Irwin in his late 70's. Of course, I must mention a young slip of a girl Alex Audibert in her forties' who volunteered to take over the essential role of a treasurer collecting, checking, balancing and banking the players fees into Baddy Canterbury. Alex had a tough during the Summer League due to problems with the Eftpos machine. It took Alex some weeks before the mess was sorted out and the books balanced.

Outside of these organising group of players we have so many other willing and special people all volunteers who willingly stood up when needed over the last 6 years

I am unable to recall all the volunteers, it's an age issue. But a few of them are Lyn van den Bosch, Jacqui Taylor, Nikita Jhildiyal, Sarah Burt, Murry and Julia Eves, Pam Bader, Jared Philips, Mandi Selen and Grant Brown who with two hours' notice stood in for me during the presentation of prizes for the 2021 Winter League and again at 1 hour notice stood in for Matt Selen to present the prizes to the players in the 2021 Sumer League competition.

Finally, there are so many other people/ players who have helped out who at the time of writing this Social Grade report I am unable to recall. But I know we really have a special and great group of players. Not to forget the office manager Lou Satherley who is very willing and happy to support the Social Grade competitions.



1. STATEMENT OF ACCOUNTING POLICIES

The financial statements presented here are for Badminton Canterbury Incorporated, a Charitable entity under the Charities Act 2005.

Badminton Canterbury Incorporated has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000.

The financial statements have been prepared on an accruals and historical cost basis, with the exception of certain items for which specific accounting policies have been identified.

(a) Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with the previous year.

(b) Fixed Assets & Depreciation

All fixed assets are initially recorded at cost (with the exception of the Hall & Buildings which were revalued in October 2016) with depreciation being deducted on all tangible fixed assets other than freehold land, in accordance with rates set out in the Income Tax Act 2007.

(c) Goods & Services Tax

The financial statements have been prepared on a GST exclusive basis with the exception of accounts receivable and payable which are GST inclusive.

(d) Income Tax

Badminton Canterbury Incorporated is registered as a charitable entity under the Charities Act 2005 and is therefore wholly exempt from paying income tax having fully complied with all statutory conditions for these exemptions.

(e) Receivables

Receivables are stated at their estimated realisable value. Bad debts are written off in the year in which they are identified.

2. COMMITMENTS & CONTINGENCIES

At balance date there are no known commitments or contingent liabilities (2020:\$0).

3. EVENTS AFTER BALANCE DATE

There were no events that have occurred after balance date that would have a material impact on the Performance Report.

2021-2022 STRATEGIC FOCUS

Last year we were appreciating being sheltered from the effects of covid. By the end of 2021 we were feeling it, with events postponed/cancelled and rescheduled. Operationally, we changed to Pay2Play for hall access in August, and while learning and getting used to a new system has it's challenges, we can say it is working far better. So far we have had zero call outs where the system had failed – prior to this we were getting one every three to four weeks. This system has also saved us considerable administrative time in issuing cards, and giving the player/customer better control over their account and their own money.

The other fundamental change was to move from MYOB for our accounts to Xero. Among many other reasons, we identified people opting to, or being required to work from home, cloud based solutions are essential. There are many other reasons for this change that I won't detail here. In addition, we enlisted in Friendly Manager, a new database to help us run programs, and communicate with players. BC needs to move with the times, and utilize technology to improve what we do.

Effective communication has been a battle with BC for as long as I can remember. We are determined to improve in this area, and the database is a first step in that. Also being cloud based, this allows us to offer coaches access to attendance registers no matter where they are, and all those working for BC the ability to get in touch with people directly. FM also has substantial efficiencies for payments of players – stopping a lot of double handling and late invoicing. We believe the efficiencies gained in this area alone will cover the monthly investment in FM – and more importantly it allows us to grow and reach more people without a heap more administrative time.

From operations, back to the focus of this page, which is more overall strategic information. This page is normally a bit reflective, but somewhat forward thinking too as that is what strategic focus needs to be about. The main reflection I take out of the last couple of years is that normal is no more, and we need to be prepared. Sports need to be adaptable, flexible, and meet the needs of the modern athlete/player/customer. Blanket *no refund* policies no longer work. Expecting people to turn up week after week after week is not realistic, and who has the volunteer hours that have traditionally been required to keep a minority sport going? I am aware our clubs are volunteer driven and these effects happen in our clubs as well as BC.

So this leaves us in a position of having improved our day to day business (we still have plenty of mahi ahead of us), but also thinking where to from here? What direction does BC go in? How do we get there? Where is a minority sport best to spend it's resources (that is not just money resources either). And how do we get bigger resources so we can keep the momentum growing?

At the end of 2021, with the support of Sport Canterbury we have engaged another independent review of BC, to guide our next strategic plan (the last one was completed 2014, covering to 2018, and we completed an internal review in 2019 to cover the next two years). So right now I can't share much with you as this process is happening right now. Except to say we (that is the Board, and the staff here at BC) are committed to this process with an open mind and firm action with accountability to our clubs for the outcome of Vaughan's report.

Our previously 5 identified areas are below, what will our future contain? How will these areas be key to what drives Badminton in Canterbury?
